

Boney Kapoor plans film city near Jewar airport site

Greater Noida: Movie producer **Boney Kapoor** has expressed interest in acquiring 30 acres near the proposed Jewar airport to set up a film city.

Kapoor is expected to visit the area sometime next week, accompanied by his architect. YEIDA officials said Kapoor had shortlisted another site in



Lucknow and was expected to choose any of the two plots during his visit. "We have scheduled a visit to Jewar next week. I will visit the project site. We are yet to finalise the dates," Kapoor told TOI.

Sandeep Marwah, founder of Noida Film City, said Jewar was a viable option for develop-

ing a second film city in the area as no land was available in Noida to expand the existing facility. Kapoor's interest in developing a film city in UP goes back to February, when the state government had organised a two-day investors' summit in Lucknow, said Shailendra Bhatia, OSD at YEIDA. Bhatia said Kapoor had then signed an MoU with the UP government to develop a film city.
